

SECTION 2 — HAZARDS IDENTIFICATION

Hazard class: Acute toxicity, oral and dermal (Category 5). May be harmful if swallowed or in contact with skin (H303+H313).

Hazard class: Serious eye damage or irritation (Category 2B). Causes eye irritation (H320).

SECTION 4 — FIRST AID MEASURES

SECTION 7 — HANDLING AND STORAGE

Flinn Suggested Chemical Storage Pattern: Inorganic #2. Store with acetates, halides, sulfates, sulfates, thiosulfates and phosphates.

Absorbs moisture from air. Keep container tightly closed. Store in a cool, dry place within a Flinn Chem-Saf™ bag.
