SECTION 4 — FIRST AID MEASURES

SECTION 5 — FIRE FIGHTING MEASURES

Nonflammable solid but decomposes above 160 °C (320F) producing highly flammable/explosive acetone.

When heated to decomposition, may emit toxic fumes.

In case of fire: Use a tri-class dry chemical fire extinguisher.

SECTION 7 — HANDLING AND STORAGE

Flinn Suggested Chemical Storage Pattern: Inorganic #2. Store with acetates, halides, sulfates, sulfites, thiosulfates and phosphates.

Store in a cool, dry place.

Wear protective gloves, protective clothing, and eye protection. Wash hands thoroughly after handling.

White powder. Slight acetic acid odor.

Decomposes above 160°C producing calcium carbonate and flammable acetone vapor.
