## SECTION 4. FIRST AID MEASURES

### 4.1. Description of first aid measures

**Inhalation:** Remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Call a physician.

**Chronic Exposure:** Prolonged contact with dilute solutions or mists has a destructive effect upon tissue.

## SECTION 5. FIREFIGHTING MEASURES

### Suitable and Unsuitable Extinguishing Media:

Flash point: >212°F/100°C. Foam, CO2, dry chemical or other media suitable for the primary source of the fire.

### Special Equipment and Precautions for Fire –Fighters:

In the event of a fire, wear full protective clothing and NIOSH-approved self-contained breathing apparatus with full face-piece operated in the pressure demand or other positive pressure mode. Contents under pressure may explode from excessive heat. Exposure to temperature above 120°/49°C may cause bursting.

## SECTION 6. ACCIDENTAL RELEASE MEASURES

**Personal Precautions, Protective Equipment and Emergency Procedures:** Ventilate area of leak or spill. Keep unnecessary and unprotected people away from area of spill. Wear appropriate personal protective equipment and clothing during clean-up.

**Methods and Material for Containment and Clean-Up:** Contain and recover liquid when possible. Do not flush caustic residues to the sewer. Residues from spills can be diluted with water, then neutralized with dilute acid such as acetic, hydrochloric or sulfuric. Absorb neutralized caustic residue on clay, vermiculite or other inert substance and package in a suitable container for disposal. do not use aluminum tools to collect absorbed material or aluminum containers to store collected waste. US Regulations (CERCLA) require reporting spills and releases to soil, water and air in excess of reportable quantities (700 gallons) of this product. ## SECTION 7. HANDLING AND STORAGE

**Precautions for Safe Handling:** Store locked up in a well-ventilated area. Protect container from sunlight. Never store in a vehicle. Do not expose to temperatures above 122 0 F or 50 0 C. Keep upright without excessive load on top.

### Appropriate Engineering Controls:

A system of local and/or general exhaust is recommended to keep employee exposures below the Airborne Exposure Limits. Local exhaust ventilation is generally preferred because it can control the emissions of the contaminant at its source, preventing dispersion of it into the general work area. ## SECTION 10. STABILITY AND REACTIVITY

**Chemical Stability:** Stable under ordinary conditions of use and storage.

**Possibility of Hazardous Reactions:** Will not occur.

**Conditions to Avoid:** Extreme heat, incompatibles.

**Incompatible Materials:** Sodium hydroxide in contact with acids and organic halogen compounds, especially trichloroethylene, may cause violent reactions. Contact with nitro methane and other similar nitro compounds causes formation of shock-sensitive salts. Contact with metals such as aluminum, magnesium, tin, and zinc cause formation of flammable hydrogen gas. Sodium hydroxide, even in fairly dilute solution, reacts readily with various sugars to produce carbon monoxide.

**Hazardous Decomposition Products:** Sodium oxide. Decomposition by reaction with non-ferrous metals releases flammable and explosive hydrogen gas.
